

APPEARANCE RELEASE

I, the undersigned, enter into this Agreement with _____ herein referred to as "Producer".

I expressly release and indemnify Producer and its officers, employees, agents and designees from any and all claims known and unknown arising out of or in any way connected with the above granted uses and representations. The rights granted Producer herein are worldwide, in perpetuity.

4. This agreement expresses the entire understanding between myself and Producer. Any laws that require or suggest that the interpretation of a document or agreement, or the resolution of any ambiguities contained therein, should be resolved against the drafter of the document or agreement, are hereby waived. No modification, alteration or amendment of this agreement will be valid or binding unless in writing and signed by both myself and the Producer. No waiver by Producer of any term or condition of this agreement will be construed as a waiver by Producer of any other term or condition. Producer may freely assign, in whole or in part, any of their rights or obligations under this agreement. I may not assign my rights and obligations under this agreement.
